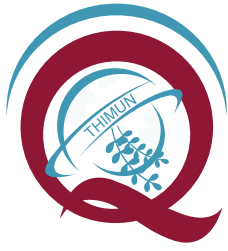

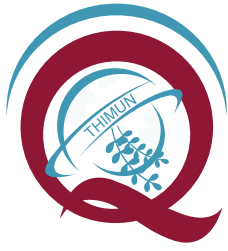

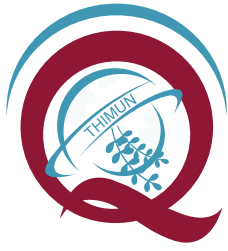

The Willow Project

Developmental disabilities refer to a range of conditions that affect a person's physical, intellectual, or social development. These

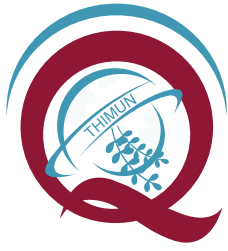

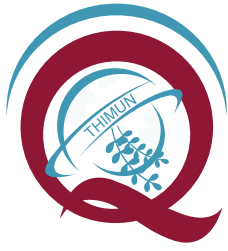
Innaya (editing): My favourite part of my job is being able to turn a vision for a video into reality. I love the process of seeing all the clips come together and form something memorable for people to take away.
